Mr. Courtade explained that membership numbers had decreased in February, due to the fact that members are suspended at that time if they have not paid their dues. 624 active and 100 inactive were suspended for non payment of dues and since February 18, 294 active and 25 inactive members have been reinstated and 700 new attorneys have joined the Bar.

Ms. Fershtman provided the Board with a historical perspective on the appointment of members to the ABA House of Delegates nomination. A motion was offered and supported to reappoint Ms. Vanessa Williams Peterson as the SBM representative to the ABA House of Delegates. Motion carried.

Mr. Escobedo reported that the April 2009 Bar Journal will be mailed to members next week. He noted that the number of pages in this publication has decreased by 100 and that the paper used is more environmentally friendly than previous directories.

Ms. Escobedo indicated that the member benefit from Harleyville insurance has been discontinued.

**President's Report**, Edward H. Pappas, President  
Board Officer Election Procedure, Matrix and 2009 Timeline
