Quorum was not met for action items.

1. Paul Raine introduced two items of pressing business. The review of court rules 2002-37 and MRE 902A. Paul explained the urgency of the reviews. Judge Tabbey discussed 2002-37 and commented on the importance of acceptability using an open system, the need for SCAO, need for court to be able to image paper, and identifying rules for the access to records. Also, he updated on the Berrien/Washtenaw 2 year project with Unisys that uses a single source case management system and platform for e-mailing. The need to use uniform definition in the rules was another comment from Judge Tabbey. The definition of signature, computer, etc. may be different in the rules and they should not contradict. Judge Tabbey offered to write down his thoughts and comments on 2002-37 for the committee.
2. The eFiling survey was discussed. The committee requested the 2005 survey results. Will Kramer will e-mail them to the committee.
3. Both Vincent Polley and Paul Raine are going to work together on surveying Bar Associations. Will Kramer is to get a list of Bars with a Technology Committee for Vincent and Paul.
4. Steve Grey has offered to setup a ListServ for the Technology Committee.
