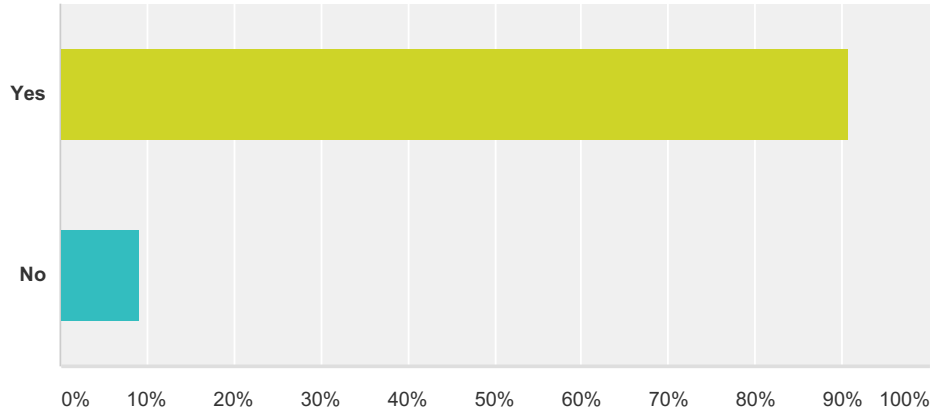


Q1 Are you generally in favor of electronic voting at in-person meetings of the Representative Assembly (RA)?

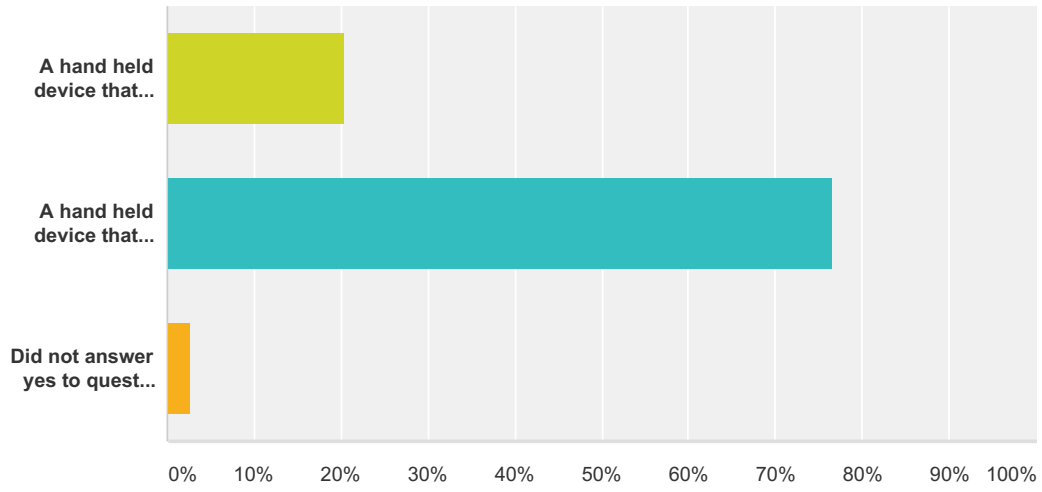

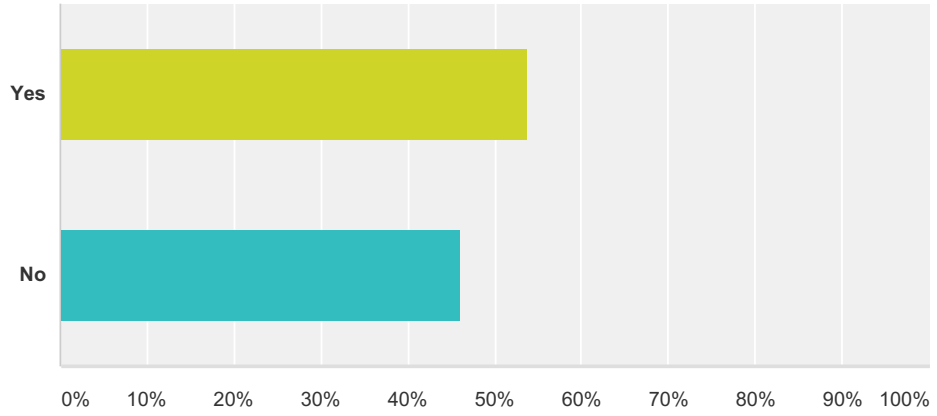

Q3 Are you generally in favor of the RA allowing remote electronic voting outside of in-person meetings?

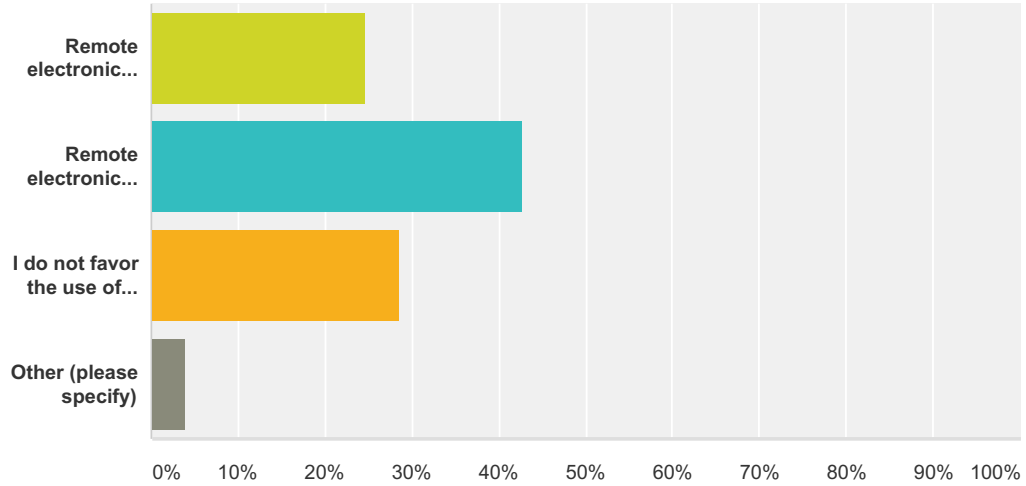

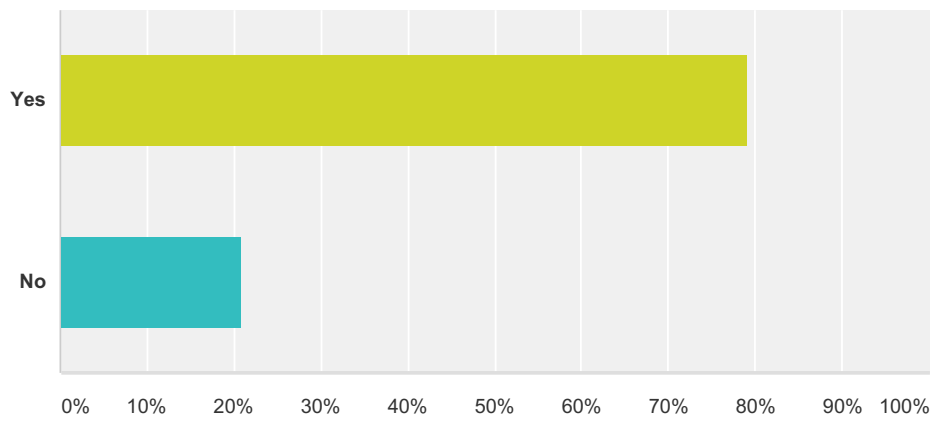

Q5 Are you generally in favor of using electronic communications between members about topics relevant to the RA outside of in-person meetings of the RA?

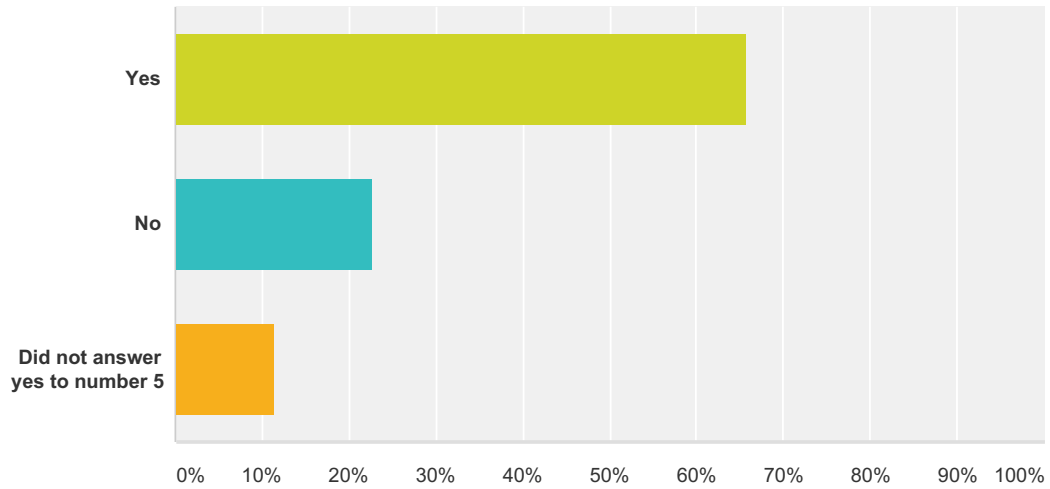
