NOTE: Following approval of nominations, all newly appointed members' terms will be **for the April 9, 2011 and September 15, 2011 meetings only. You must fill out and submit your petition for election to finish your term.**

Individuals appointed to fill vacancies with terms expiring at the close of the 2011 Annual Meeting are interim appointees. In order to retain the Assembly seat for a new three-year term (expiring 2014), interim appointees **MUST** submit a completed Assembly Petition to the State Bar of Michigan by April 30, 2011.

Individuals appointed to fill vacancies with terms expiring at the close of the 2012 or 2013 Annual Meeting are interim appointees whose terms are only effective for the April 9, 2011 and the September 15, 2011 meetings. The remainder of the term will be open for election. Interim appointees **MUST** submit a completed Assembly Petition to the State Bar of Michigan by April 30, 2011 in order to retain the Assembly seat through 2012 or 2013.
