Consumer Law Section

The section provided testimony opposing the repealing of the Michigan pre-foreclosure negotiation provisions—the “90-day law.” See Senate Bills 380, 383; and House Bills 4765, 4766. Of significance, SB 383 created an inherent right for the purchaser at a sheriff’s sale to inspect the exterior and interior of the homeowner’s property during the redemption period. On July 3, 2013, the governor signed into law these amendments that will take effect January 10, 2014.
