- Attorneys wishing to change their status (active, inactive, emeritus, or resigned) or requesting a military waiver, cannot pay their dues online this year. You must complete the paper invoice, click "print paper invoice" if needed, and follow the instructions for status change or military waiver.
- The only credit and debit cards accepted are VISA and MasterCard.
- Members who pay their dues online are not required to submit a signed paper invoice to the State Bar of Michigan office.
