Under the leadership of Russell Prins, the Section's Standing Committee on Land Title Standards has brought this invaluable resource into the electronic age and will greatly extend its impact on Michigan jurisprudence. Administration: Arlene Rubinstein continues to excel as the Section's Administrator. Arlene is the cornerstone of the Section's accomplishments during the past year.

Special Committees: This year the Section tried something entirely different with respect to the special committees - it made an effort to break out of Southeastern Michigan. Most of the Section's special committees are now co-chaired by a lawyer from each side of the state, bringing a broader range of insight and experience to the Section. Councilmember Kim Shierk devoted a tremendous amount of time and effort to this initiative, which has helped ensure the Section's development as a truly statewide institution. Melisa Collar, Nyal Deems and John Cameron also played important behind-the-scenes roles in helping recruit talented co-chairs from across the state.

Communications: The Section continues to make great strides in its use of technology. The RPLS Council now routinely includes remote attendees as part of its monthly meetings through use of web-conferencing. The Section's partnership with ICLE has allowed our Homeward Bound series to viewed over the internet from anywhere in the world. With the help of Councilmember Howard Lax, the Section is also in the process of developing an internet bulletin-board for use by the special committees. Continuing improvements in technology will help the Section incorporate lawyers from all across the State more directly into its educational and governance activities.

Continuing Legal Education: The Section's continuing legal education program continues to grow and prosper thanks to the efforts of Councilmember David Nykanen and Homeward Bound Chair Richard Rattner. The Section's relationship with ICLE has never been stronger or more positive, thanks in great part to Kay Holsinger's involvement. The Section has extended its existing contract with ICLE for an additional two years and looks forward to developing stronger bonds in the future. The Winter Conference continues to flourish, this year thanks to the efforts of Marie Racine and Greg Gamalski. The Summer Conference is well on its way to another success, thanks to the leadership of Dawn Patterson and Melissa Collar.

Strategic Partnerships: During the past year the Section vigorously pursued creative partnership opportunities with other legal and professional organizations.
